**1. Who is the legal governing board of Family, Career and Community Leaders of America?**

*The National Board of Directors. The board determines policy, oversees financial affairs, evaluates current programs and assists in long-range planning and organizational management. Members are both appointed and elected.*

**6. What are the four national FCCLA regions?**

*North Atlantic, Southern, Central, Pacific*

**8. What is the mission of FCCLA?**

*To promote personal growth and leadership development through family and consumer sciences education. Focusing on the multiple roles of family member, wage earner and community leader, members develop skills for life through – character development; creative and critical thinking; interpersonal communication; practical knowledge; and career preparation.*

**9. How many national officers are elected?**

*10*

**10. What are the five basic components of an FCCLA chapter?**

*Membership, adviser, leadership, meetings and projects*

**11. Who is eligible to be a member of FCCLA?**

*Any student who is taking or has taken a Family and Consumer Sciences education course and who pays the appropriate membership dues.*

**12. What is FCCLA?**

*Family, Career and Community Leaders of America is a dynamic and effective national student organization that helps young men and women become leaders and address important personal, family, work and societal issues through family and consumer sciences education.*

**13. What is the planning process?**

*A simple five-step method to help chapter members and advisors plan individual, group or chapter projects and activities*

**14. What is a program of work?**

*Chapter's plans for the year*

**15. What is youth-centered leadership?**

*A process through which youth members are responsible for planning, carrying out and evaluating chapter projects and activities*

**16. What are the eight purposes of FCCLA?**

- 1. To provide opportunities for personal development and preparation for adult life.*
- 2. To strengthen the function of the family as the basic unit of society.*
- 3. To encourage democracy through cooperative action in the home and community.*
- 4. To encourage individual and group involvement in helping achieve global cooperation and harmony.*
- 5. To promote greater understanding between youth and adults.*
- 6. To provide opportunities for making decisions and for assuming responsibilities.*
- 7. To prepare for the multiple roles of men and women in today's society.*
- 8. To promote family and consumer sciences and related occupations.*

**17. What are the 49 state associations?**

*46 states, the District of Columbia, the American Virgin Islands, and Puerto Rico*

**18. Who is the current executive director of FCCLA?**

*Sandy Spavone*

**19. What is the role of a chapter president?**

*Presides over the chapter during meetings, project selection and planning; appoints committees or members for specific jobs related to projects and serves as an ex-officio member of such committees.*

**20. What is the role of the chapter vice-president?**

*Assists the president in overseeing the work of project committees; fills in when the president is absent.*

**21. What is the role of the chapter secretary?**

*Maintains written minutes of the decisions related to projects and activities; works with president to complete a written Planning Process worksheet to be posted for member review.*

**22. What is the role of the chapter treasurer?**

*Collects and records all fundraising monies and dues; maintains written records and receipts for all funds spent on chapter project(s).*

**23. What are bylaws?**

*Bylaws are the rules adopted by an organization for governing its activities.*

**24. What are the four kinds of membership in FCCLA?**

*Active, Alumni, Associate and Honorary*

**25. How many members are needed to form a chapter?**

*There is no minimum requirement; however, must be paid for a minimum of 12 members.*

**26. Can students in private schools be members of FCCLA?**

*Yes, as long as they meet membership requirements.*

**27. What are the three methods of voting?**

*Voice, roll call, or ballot*

**28. What is a quorum?**

*Minimum number of members that must be present to conduct the business of the meeting; usually a simple majority unless otherwise specified in the bylaws.*

**29. How is FCCLA financed?**

*FCCLA is a nonprofit organization supported by student membership dues in addition to funds raised from individuals, corporations, foundations, and federal grants.*

**30. What is affiliation?**

*The process of formally joining FCCLA by paying membership dues.*

**31. Who is eligible to use the names “Family, Career and Community Leaders of America” and “FCCLA”, as well as the emblem?**

*Only affiliated (dues paying) members and chapters.*

**32. What does the FCCLA emblem represent?**

*The FCCLA emblem represents Family, Career and Community Leaders of America as a dynamic, active organization. The dominant collegiate lettering articulates a focus on education and student leadership. The swooping arch embodies an active organization that moves toward new arenas. The color of the emblem is one of the organizational colors – red.*

**33. What are the official FCCLA colors and what do they represent?**

*Red suggests strength, courage and determination – personal qualities leading to happiness through a positive self-image.*

*White symbolizes sincerity of purpose and integrity of action, qualities that will help individuals build a better tomorrow.*

**34. What is the FCCLA flower and what does it represent?**

*The red rose represents the organization because it gives joy through its beauty and fragrance. It symbolizes a desire for beauty in everyday living.*

**35. What is the FCCLA motto?**

*Toward New Horizons*

**36. Repeat the creed.**

*We are the Family, Career and Community Leaders of America.*

*We face the future with warm courage and high hope.*

*For we have the clear consciousness of seeking old and precious values.*

*For we are the builders of home,*

*Home for America's future,*

*Homes where living will be the expression of everything that is good and fair,*

*Officers: "Focusing on the multiple roles of family member, wage earner, and community leader, members develop skills for life through character development, creative and critical thinking, interpersonal communication, practical knowledge, and career preparation."*

*Members: "As we work toward the accomplishment of our goals, we learn cooperation, take responsibility, develop leadership, and give service."*

*President: "This meeting of the \_\_\_\_\_ Chapter of Family, Career and Community Leaders of America is now in session. You may be seated." (Raps gavel)*

**38. What is the standard FCCLA Closing Ceremony?**

*President: "Members, please stand. FCCLA members, we are challenged to accept the responsibility of making decisions that affect our lives today and the world of tomorrow. Let us repeat our creed."*

*Members: "We are the Family, Career and Community Leaders of America.*

*We face the future with warm courage and high hope.*

*For we have the clear consciousness of seeking old and precious values.*

*For we are the builders of home,*

*Home for America's future,*

*Homes where living will be the expression of everything that is good and fair,*

*Homes where truth and love and security and faith will be realities, not dreams.*

*The pin is worn over the heart. Members, advisers, honorary members, Alumni & Associate member and chapter parents may wear the pin.*

**41. Who is considered one of the most influential leaders in the founding of Future Homemakers of America?**

*Edna P. Amidon, an educator and promoter of home economics education. She served as the organization's first board chair.*

**42. Who was the first national adviser?**

*Dr. Hazel Frost*

**43. What was the amount of the first dues in 1945?**

*10 cents*

**44. When and where was Future Homemakers of America founded?**

*June 1945 in Chicago, Illinois*

**45. What is the name of the organization's magazine, and when was it first published?**

*Teen Times was first published in 1945.*

**46. The first national convention was held where and when?**

*July 1948 in Kansas City, Missouri*

**47. How many students are involved in FCCLA?**

*More than 235,000 chapter members in more than 4900 local chapters. Today, more than ten million youth have been involved in the organization since its founding in 1945.*

**48. What is the organization's central focus?**

*The family*

**49. When did the Future Homemakers of America and the New Homemakers of America merge?**

*July 1965*

**50. When were HERO (Home Economics Related Occupations) chapters founded?**

*1971*

**51. In what year were STAR Events introduced? What were the first three STAR Events developed?**

*1983*

*Job Interview, Illustrated Talking, and Chapter Activities*

**52. When and where was the name of the organization changed to Family, Career and Community Leaders of America?**

*July 1999 in Boston, Massachusetts*

**53. Why did FHA/HERO change its name to FCCLA?**

*FCCLA reflects the organization's mission, emphasizing the leadership qualities that set members apart from other young people.*

**54. Missouri was chartered as a state association in what year?**

*April 1946 – Missouri is the 29th chartered state association.*

**55. Involvement in FCCLA offers members the opportunity to expand their leadership potential and develop skills for life. What are skills for life necessary in the home and workplace, as identified by National FCCLA?**

*Planning, goal setting, problem solving, decision making and interpersonal communication*

**56. What qualifications are needed to be a chapter adviser?**

*Certified in Family and Consumer Sciences Educator, or currently teaching FCS classes*

**57. What is the amount of state dues?**

*\$4.00 per person, though \$2.00 of this amount is refunded back to the region*

**58. Who is eligible for Alumni & Associates membership?**

*Former FCCLA, FHA (Future Homemakers of America), NHA (New Homemakers of America), HERO members, and individuals who share the goals and purposes of Family, Career and Community Leaders of America.*

*Parliamentary Procedure, using Robert's Rules of Order*

*A peer education program that helps members learn more about themselves, the workplace, and careers so that they can put themselves on the pathway to future success*
