Opportunities for Advisers

We are working hard to provide several opportunities for advisers at Fall Leadership Conference!

All advisers to regional first vice presidents are required to attend a STAR Events Management Orientation, either in-person or virtually. Any adviser required to attend not in attendance will be ineligible to manage regional STAR Events, and the state office will take over management in these cases.

The annual Chapter Adviser Summit will be Sunday evening and Monday morning and be full of everything-FCCLA...chapter management, member motivation, recruitment, balance, and more!

Registration

- The regular registration deadline is **TODAY (September 21)!!** Registration information is found on the Missouri FCCLA website > Attend > Fall Leadership Conference.
- Registrations will be accepted until September 28, however registrations submitted after the September 21 regular registration deadline will incur a \$25 late fee and will not be guaranteed all the conference swag!
- For registration, you **must submit affiliation before registering**. You do not have to PAY your invoice, but you must submit. You can create additional invoices and submissions later, and pay all invoices with one check when you're done affiliating everyone.
- The **emergency contact** for each person should be someone **off-site**. For students, it should be a parent or guardian.

Why?

Why are there so many questions on registration?

All of the individual and chapter questions on registration help us make sure you and your members will have the safest and most positive experience possible at Missouri FCCLA events. Our members love the ribbons and some of these questions provide us with information to spotlight new members, seniors, first-time conference attendees and more with the ribbons they love!

Why do I need to do a consent and release form?

The Missouri Department of Elementary and Secondary Education requires this form from all CTSO conference attendees.

Why do I need to upload the consent and release form AND bring them with me?

You upload the forms for Missouri FCCLA's records and you should have the forms on-site with you for your records. This ensures that, should an issue arise while on-site, you have the records readily available and if an issue arises after the conference, the state office has the readily available for reference as well.

Why can't I be the emergency contact? Why does the emergency contact have to be off-site?

Should an emergency situation arise, it is important that we are able to contact the on-site adult as well as the student's parent/guardian. When creating this policy, I thought about my own child - if he had an emergency, I would want know immediately. Having an at-home emergency contact allows us to do that.

What Next?

You're registered for Fall Leadership Conference and your hotel rooms are reserved at Tan-Tar-A! Now what? Here's what to do now:

- Review the **Consent & Release Form** and the policies included with **all conference attendees** and their families. Have the forms signed by the appropriate individuals, and then submit a copy of all forms for your chapter to the link provided at missourifccla.org > Attend > Fall Leadership Conference by **September 28**. We only need the first page of the form (the page with the signatures)
- Finalize and submit your **rooming list** by **September 28**. A template and submission link at missourifccla.org > Attend > Fall Leadership.
- If you *will not have the credit card you reserved your hotel rooms with at the conference and/or you want to skip the check-in line to pick up your room keys with your conference registration*, request a **Credit Card Authorization Form** from Margaritaville and submit it by **September 28**.
- Keep on eye on the Missouri FCCLA website and your email for updates as we get closer to conference.
