ELIGIBILITY INFORMATION

1. Each chapter may submit three (3) entries in each level of this event. Entries will be available on a first-come, first-serve basis. The conference facility and schedule will determine the number of entries.
2. Participation is open to any fully affiliated FCCLA member.
3. Participants must be registered to attend the Missouri FCCLA State Leadership Conference.
4. Participation is open to any fully affiliated FCCLA member, with dues paid by the December 1 annual deadline, who is classified under the provisions of Public Law 105-17, Individuals with Disabilities Education Act (IDEA), 1997.3.

GENERAL INFORMATION

1. The project and call supporting materials must be planned, conducted, and prepared by the participant only.
2. Participants will set up their display during the designated time on Sunday of State Leadership Conference.
3. Participants are not allowed to discuss the event with other participants. Doing so will result in disqualification.
4. Presentations may not be recorded or photographed during competition except by official Missouri FCCLA photographers.
5. Participants must follow the approved dress code for participation in this event.

COMPETITION PROCEDURES AND REQUIREMENTS

ALL LEVELS

- The participant will create a poster, using foam core poster board of any color, reflecting the importance of FCCLA and/or Family Consumer Sciences and Human Services (FCSHS) education to their personal growth and leadership development.
- The foam core poster board should be standard size – 30" x 40" – and may be used horizontally or vertically.
- The following must be attached to the back of the poster board:
 - One 8 ½" x 11" project identification page containing participant name, school, city, Missouri FCCLA region, and project title;
 - One 8 ½" x 11" summary page describing how each step of the FCCLA Planning Process was used in the project;
 - One 8 ½" x 11" page explaining how FCCLA has helped them in their personal growth and leadership development (200 words or less); and
 - If necessary, one 8 ½" x 11" page explaining the post elements (200 words or less).
- The participant will submit their project and the required Participant Authorization Form to the appropriate location during designated conference registration hours.
